**MINOR'S RELEASE, WAIVER OF LIABILITY, AND INDEMNITY AGREEMENT**

In consideration of allowing the minor named below to compete or participate in any way in any activity or event on the grounds of **Bluebonnet MX Park, L.L.C.**, including, but not limited to, riding a motorcycle, motorbike, or bicycle, the undersigned agrees as follows:

1. That the undersigned is a parent or legal guardian of the minor named below.
2. That the minor named below and I, as such minor's parent or legal guardian, **KNOWINGLY AND FREELY ASSUME ALL RISKS** associated with motorized or non-motorized off-road activities at Bluebonnet MX Park, for risks known and unknown, **EVEN IF THOSE RISKS ARISE FROM THE NEGLIGENCE OF THOSE PERSONS RELEASED FROM LIABILITY BELOW, AND ASSUME FULL RESPONSIBILITY FOR THE SAFETY OF THE MINOR NAMED BELOW IN CONSIDERATION OF BEING ALLOWED TO PARTICIPATE IN MOTORIZED OR NON-MOTORIZED OFF-ROAD ACTIVITIES AT BLUEBONNET MX PARK.**
3. In consideration of the minor named below being allowed to participate in motorized or non-motorized off-road activities at Bluebonnet MX Park, I do hereby waive, release, and forever discharge Bluebonnet MX Park, L.L.C., and its officers, directors, agents, employees, representatives, members, promoters, sponsors, officials, and the owners of the land on which Bluebonnet MX Park operates, from any and all responsibilities or liabilities for personal injuries or damages to the minor named below arising out of, connected with, or through such minor's participation in off-road activities, whether **CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.**
4. I understand and agree that this Release covers every motorized or non-motorized off-road activity or event in which the minor named below participates after signing this agreement.
5. **I understand that Bluebonnet MX Park, L.L.C. does not provide health insurance for participants in off-road activities. I assume all responsibility for all healthcare expenses incurred in behalf of the minor named below, including doctor, ambulance, hospital, and other medical expenses, as a result of injury due to participation in any activity at Bluebonnet MX Park or during a Bluebonnet MX Park event.**
6. In further consideration of the minor named below being allowed to participate in motorized or non-motorized activities at Bluebonnet MX Park, I hereby agree to **HOLD HARMLESS AND FULLY INDEMNIFY AND DEFEND BLUEBONNET MX PARK, L.L.C., AND ITS OFFICERS, DIRECTORS, AGENTS, EMPLOYEES, REPRESENTATIVES, MEMBERS, PROMOTERS, SPONSORS, OFFICIALS, AND THE OWNERS OF THE LAND ON WHICH BLUEBONNET MX PARK OPERATES,** from any and all claims, demands, or causes of action arising out of any injury or damage to the minor named below, including injuries or damages arising out of the **NEGLIGENCE OF OR BY ANY REPRESENTATIVE OF BLUEBONNET MX PARK, L.L.C.**
